



# Campground Conditions

**PLEASE READ:** All conditions are considered accepted upon payment of camp fees.

These conditions are advised to ensure all our guests can equally enjoy their stay at Jimna Base Camp. They are common-sense camping conditions that sadly, are not as common as one would think, these days.

Campers come here to relax and enjoy their stay. Be considerate and courteous to your fellow campers.

Technology is great, nowadays. If you like **loud music**, wear headphones!! Not everyone else wants to hear, nor may enjoy, what you want to listen to.

Again, common-sense and courtesy.

If you or someone in your group feels that they are "special" and feel they do not need to follow these basic conditions, they can and are free to leave, or if necessary, can be requested by management to pack up and depart from our campgrounds immediately without refund of camp fees.

**SPEED LIMIT:** 10 kph (walking pace).

Please drive slowly and carefully for the safety of all our guests.

**No driving in campgrounds or on the oval after dark.**

All vehicles that return after dark must park & remain in the car park until daylight for the safety of our campers. No reckless driving or hooning will be tolerated.

If it's raining or the grounds are wet, please engage 4x4 (if your vehicle has it). Drive slowly and carefully so as not to destroy the grass or create tracks. If you like playing in the mud, this is not the place.

**No after dark check-ins** unless authorised and prearranged.

**BICYCLES:** Bicycle riding after dusk is prohibited.

**GENERATORS:** Generators are only permitted between the hours of 10am-12pm and 4pm-6pm.

**CHILDREN** are to be supervised by a **RESPONSIBLE** adult *at all times* whilst on site, including the amenities block. The adult is responsible for any damage or actions of the children.

**QUIET TIME:** Quiet time is between the hours of 11:00 PM and 8:00 AM. During these hours, all children must be on their campsite and in the company of a responsible adult. Music is to cease, and campsite noise reduced to a campfire chatter.

**COMMON AREA UNDER THE OLD SCHOOL:** This area, and the facilities, are available to all campers to share between the hours of 8am-10pm daily. Please keep this area clean and tidy after use. Lights will be tuned off at 10:30pm.

**TENNIS COURT AND CHILDREN'S PLAYGROUND:** Children **MUST** be supervised by a **RESPONSIBLE** adult at all times. Only sporting equipment and plastic bottled water are permitted on the courts. No dogs, rollerblades, roller skates, bicycles, glass, soft drinks, food etc allowed in the tennis court area.

**PETS:** We are a pet-friendly campground, as we love our four-legged family members as much as you do. We do, however, ask that you respect the rules of the campground and your fellow campers. All pets must be leashed at all times whilst on site, as not all pets and owners are as friendly as the next. The pet owner is responsible for clean-up and pet behaviour, including barking. Pets (like children) should not be left unattended. Pets are not permitted in the tennis court or children's playground area, nor the toilets or showers.

**CAMPFIRES:** We know campfires are an important part of your visit with us! There are numerous small mobile fire pits available which campers can avail themselves to, or you're welcome to use your own. All campfires must be contained within the fire pit. **NO GROUND FIRES ARE PERMITTED** at any time. Firewood can be purchased at the coffee van.

**FIREPITS:** Please *do not* empty the firepits. Leave the ash in your firepits or ask Pete for advice. We are in a bushfire hazard area and need to be extra careful. Fires have actually started here because of the disposal of ash.

**COFFEE VAN** is open on the weekends from 8am-ish till late afternoon.
